Your school is part of the multi-academy trust, Sherborne Area Schools' Trust (SAST). News, celebration and event activity images may be shared on both your school's website and SAST's website.

Photos on our websites, in our brochures and other publications, or those that are part of our archive of learning activities, could continue to exist for a period of time after pupils have left school. Class or team photos that represent an historical record for the school may also be stored.

Your school or Sherborne Area Schools' Trust will not re-use any images or recordings of you that are incompatible with the original purposes explained to you. We will only use images and videos of students who are suitably dressed.

You should note that websites can be viewed around the world and not just the United Kingdom (where UK law applies). If images are copied from our websites, these can no longer be controlled by us.
